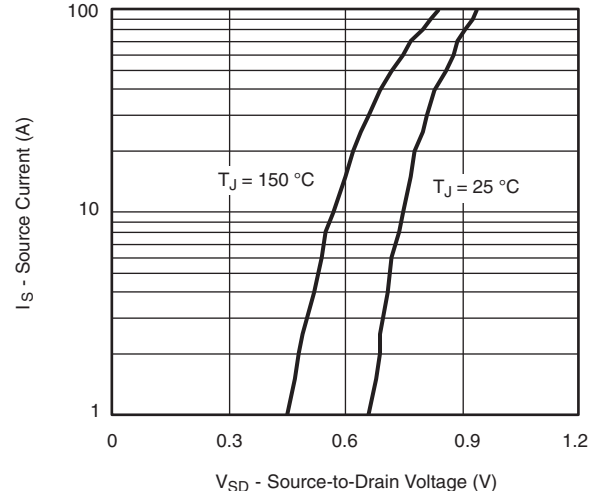

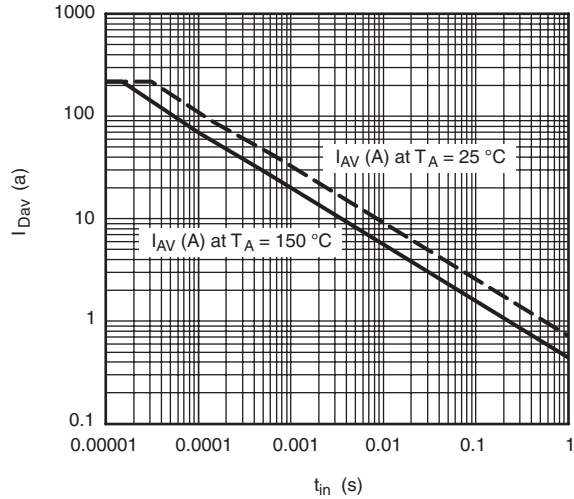

Source-Drain Diode Forward Voltage

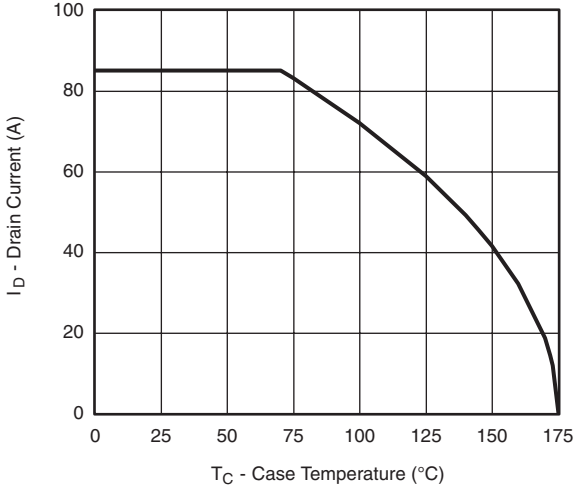


Avalanche Current vs. Time

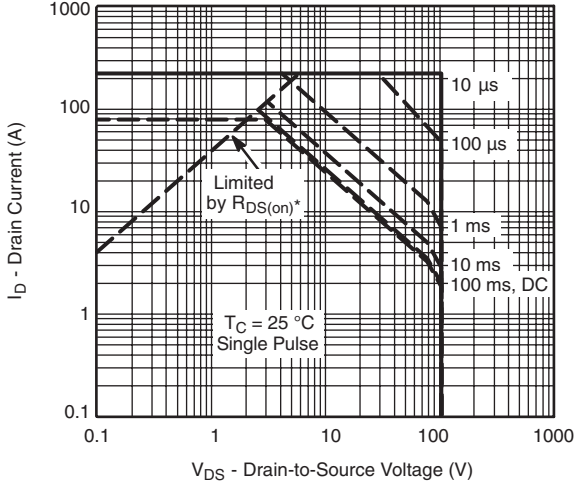


T_J - Drain-Source Breakdown vs. Junction-Temperature

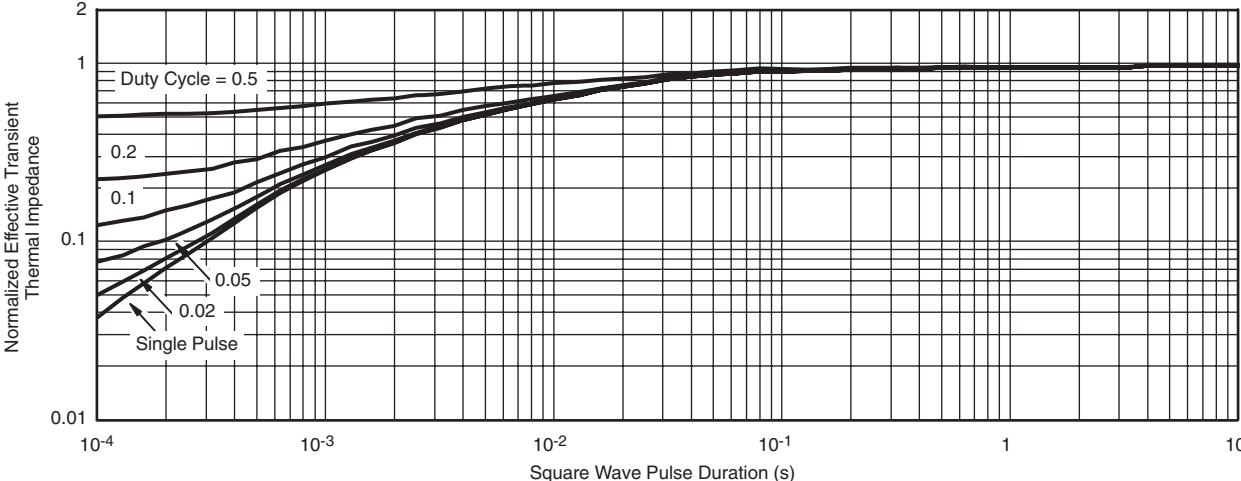

Maximum Avalanche and Drain Current vs. Case Temperature

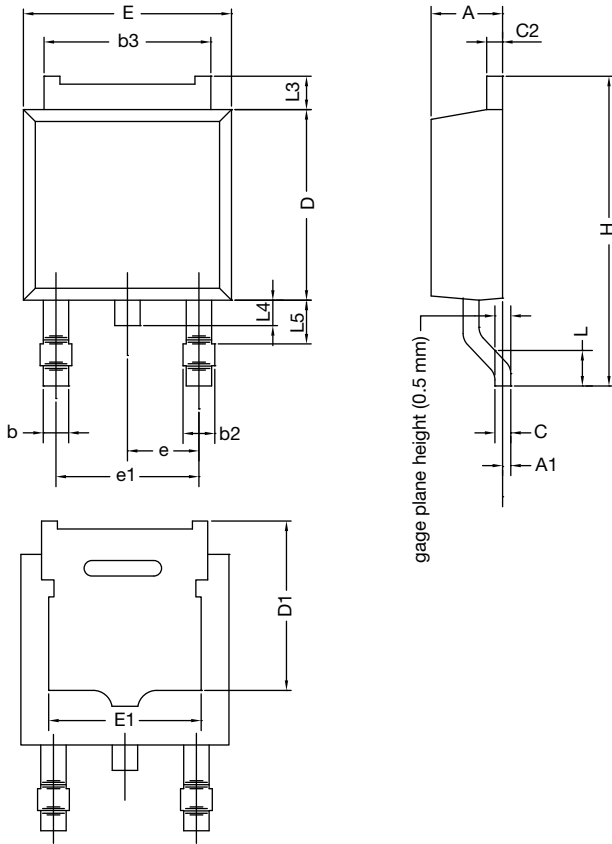

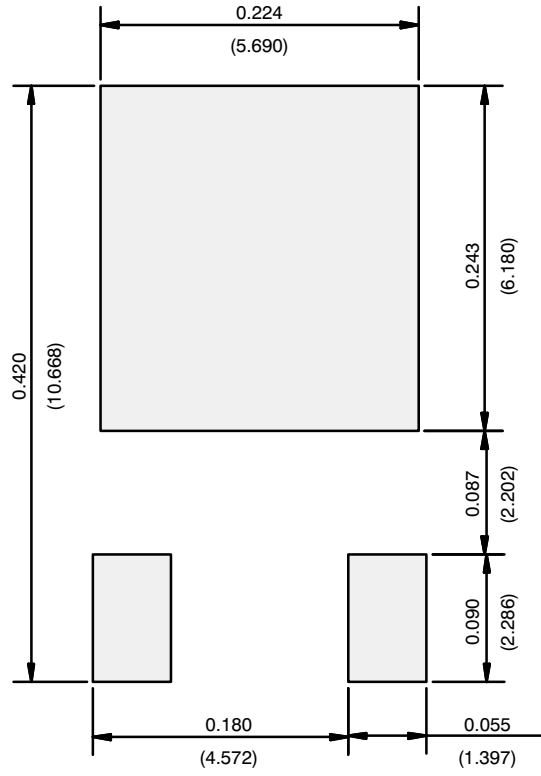
