


V_{DS} - Drain-to-Source Voltage (V) Capacitance






On-Resistance vs. Junction Temperature




 $R_{DS(on)}\, vs.\, V_{GS}\, vs.\, Temperature$



Forward Diode Voltage vs. Temperature








Safe Operating Area, Junction-to-Ambient




