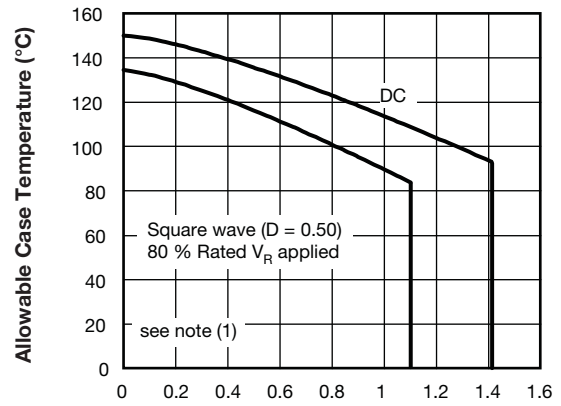

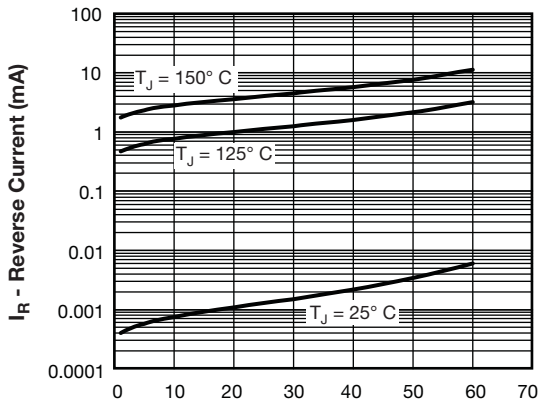

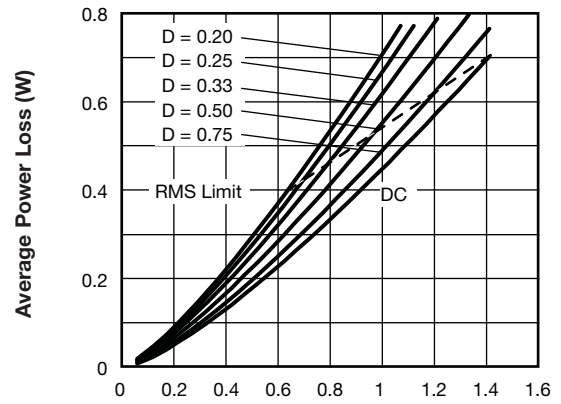
93206\_01 **V<sub>FM</sub> - Forward Voltage Drop (V)**  
Fig. 1 - Maximum Forward Voltage Drop Characteristics



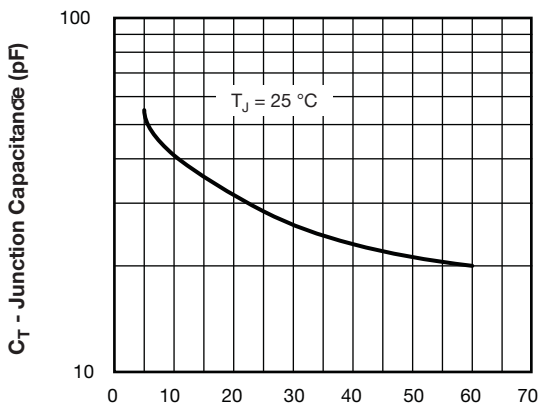
93206\_04 **I<sub>F(AV)</sub> - Average Forward Current (A)**  
Fig. 4 - Maximum Ambient Temperature vs. Average Forward Current, Printed Circuit Board Mounted



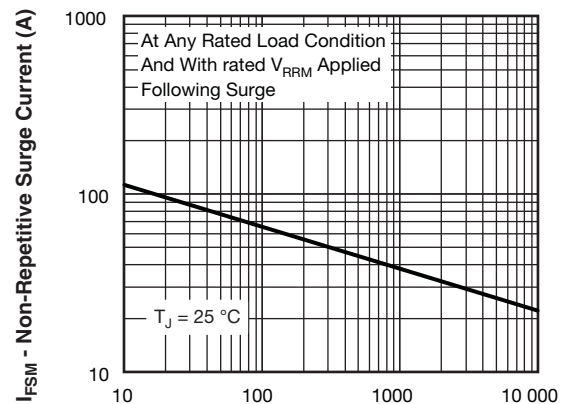
93206\_02 **V<sub>R</sub> - Reverse Voltage (V)**

Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage



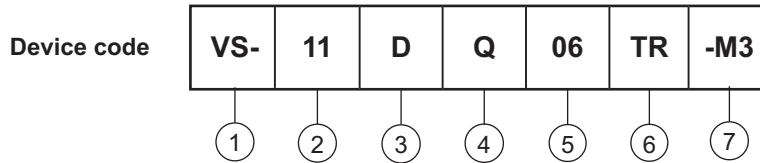
93206\_06 **t<sub>p</sub> - Square Wave Pulse Duration (µs)**
