




#### On-Resistance vs. Drain Current






V<sub>SD</sub>-Source-to-Drain Voltage (V) Source-Drain Diode Forward Voltage






Single Pulse Power, Junction-to-Ambient








Normalized Thermal Transient Impedance, Junction-to-Foot
