



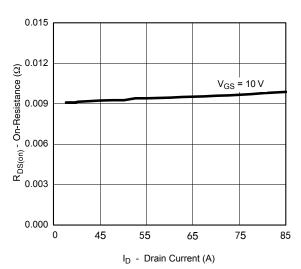






Transfer Characteristics




 $R_{DS(on)}$ vs. Drain Current



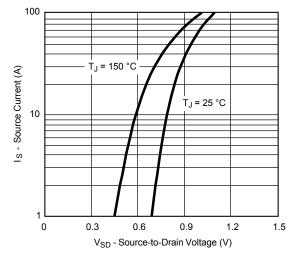
Gate Charge

Source-Drain Diode Forward Voltage

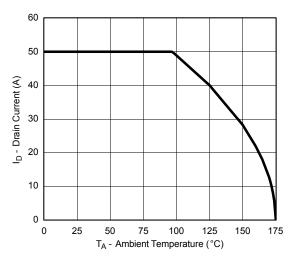


Maximum Drain Current vs. Ambient Temperature





Normalized Thermal Transient Impedance, Junction-to-Case


