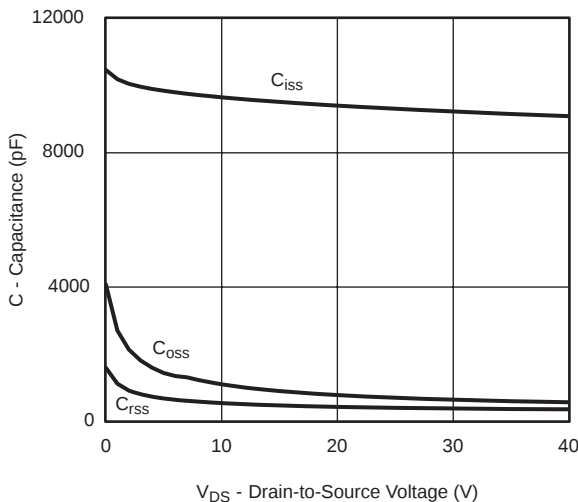

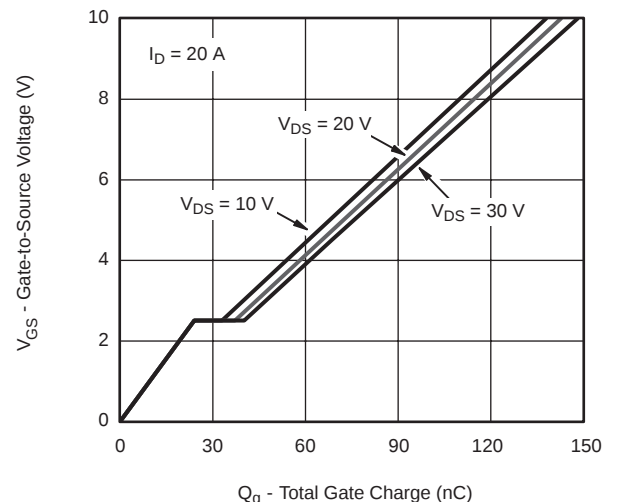
Transconductance

Capacitance

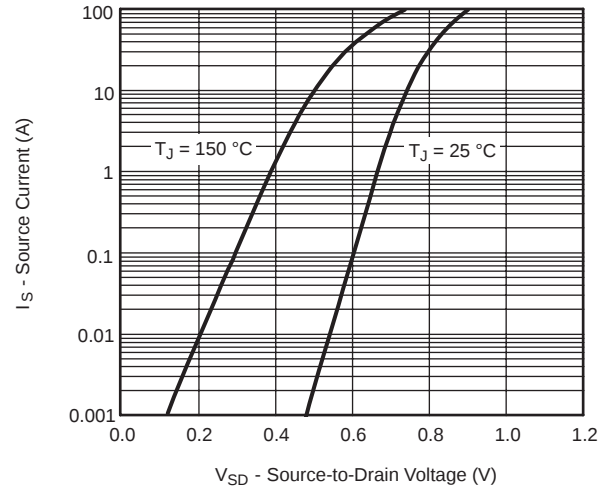

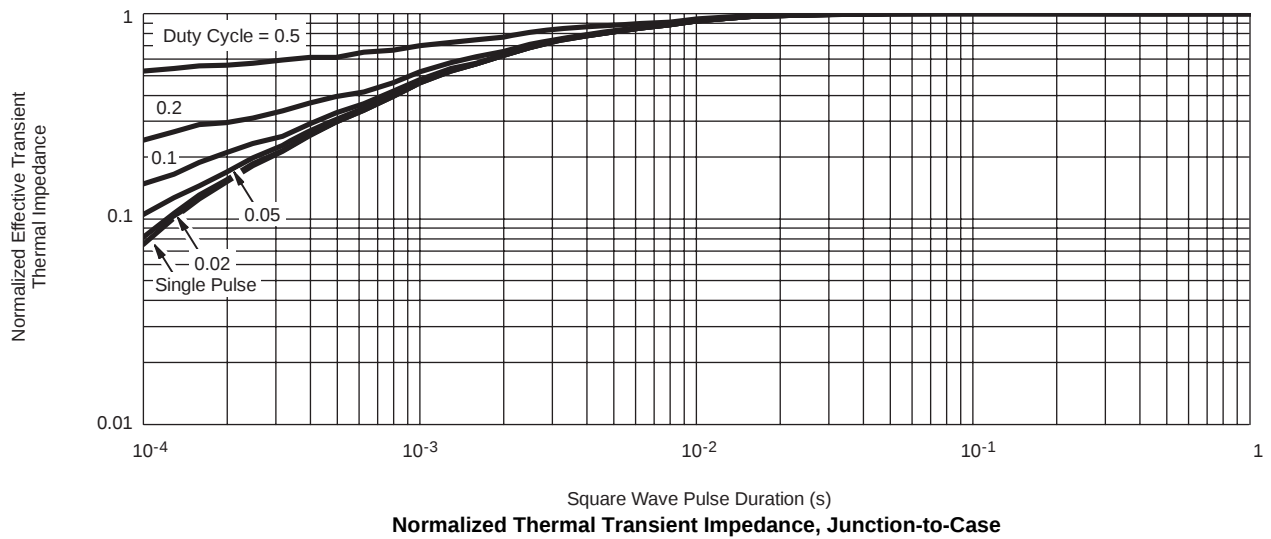

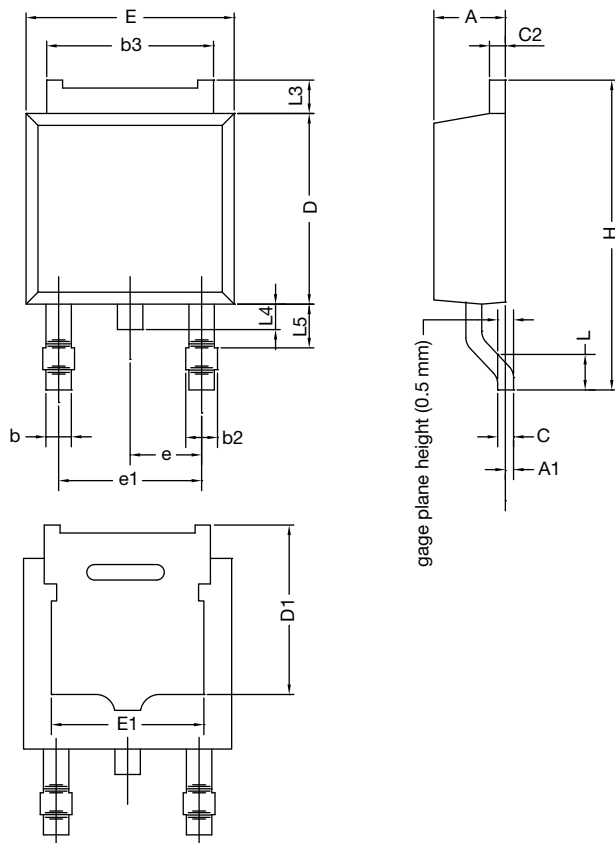
