









On-Resistance vs. Junction Temperature



Avalanche Current vs. Time




Source-Drain Diode Forward Voltage




Drain Source Breakdown vs. Junction Temperature

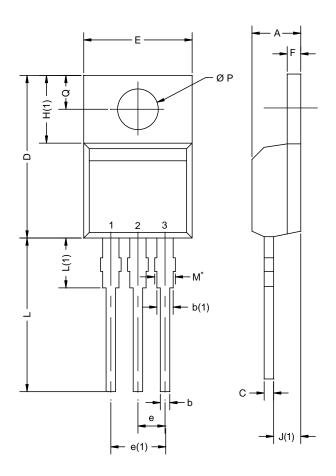
